Tanzhaus Zürich, Wasserwerkstrasse 129, Bühne 2 **House Rules**

1. Entering the rooms in outdoor shoes, trainers and stilettos is prohibited. Only socks or bare feet are allowed.
2. Cooking, eating, drinking and smoking in the rooms is not permitted.
3. The team kitchen area on the 4th floor at Wasserwerkstrasse 129 is intended for in-house residential guests and artists and may only be used by tenants by explicit arrangement with Tanzhaus Zürich.
4. The cloakrooms on the 4th floor are intended for in-house resident guests and artists and may only be used by tenants by explicit arrangement with Tanzhaus Zürich.
5. Disabled persons may use the lift. Please contact us in advance for this: info@tanzhaus-zuerich.ch , +41 (0)44 350 26 10.
6. The shutters on stage 2 at Wasserwerkstrasse 129 may not be moved single-handedly. A Tanzhaus technician must be informed in the event that the shutters have to be opened or closed. The company or tenant is liable for damage to the mechanism.
7. Nothing may be adjusted, connected or reprogrammed on the sound system. The manual for the sound system is located in the bottom drawer of the sound system.
8. If you bring your own light, sound or video material, you must register it. Please contact us in advance for this: info@tanzhaus-zuerich.ch, +41 (0)44 350 26 10 .
9. Nothing may be stuck to the walls, doors or dance floor.
10. The tenant must take back all items brought along (chairs, clothing, props, etc.) after use. Any items left behind will be disposed of (for a fee, if applicable).

11. The light switches are located in the grey box to the left of the stairs at the entrance to stage 2.
The tenant must turn switches 1, 2 and 3 by 90° for the basic light. Nothing else may be adjusted in the box.
12. The ventilation on stage 2 runs automatically.
13. After use, the tenant must sweep up, switch off the lights, turn off the sound system and lock up (entrance door to stage 2, door to backstage stage 2, door to the fire escape backstage, if applicable entrance door to the cloakroom on the 4th floor).
14. The entrance door to Wasserwerkstrasse 129 must not be wedged with objects. It must be kept closed from the start of the event.
15. There must be no dancing in the window frames.
16. The two escape routes must be kept clear at all times. No curtains may be drawn in front of them not may they be obstructed with objects of any kind.
17. The maximum capacity of people on Bühne 2 (in the room, on stage and tribune together) is 200.
The maximum of people allowed on the tribune is 120. Due to fire police standards it is not allowed to exceed these numbers.
18. Due to the risk of injury, no cloakroom may be set up under the stands.
19. The tenant shall undertake to treat the rooms and the furniture as well as the technical equipment with care. Report any damage to the furniture or the room immediately to the operations office. Any damage incurred will be invoiced. The tenant has to have a liability insurance for any damage to the premises or infrastructure.
20. Fire of any kind is prohibited in all rooms.
